Submission of bid documents closes on Monday 24th April 2017 at 2:00pm. Any bid received after the stated dates and time shall not be considered. The submitted bids will be opened on the same day Monday, 24th April, 2017 at 2:00pm at the Procurement Unit Conference Hall. Bidders and Companies representatives and interested members of the public including relevant professional bodies, Civil Societies and Non-Governmental Organizations are hereby invited to witness the public opening.

5.0 Additional information:

- i) All bids **must** be stated in Nigerian Naira.
- ii) Contractors are **not** permitted to bid for more than two (2) lots. Any bidder that violates this rule shall be disqualified and only successful pre-qualified bidders are invited for this stage of the bidding process.
- iii) The advertisement is published for information purpose, and should **not** be construed as a commitment or obligation on the part of the University to award these contracts.
- iv) The University is **not** bound to consider any bid and reserve the right to reject all bids at any time prior to the acceptance of a bid or cancel the procurement proceeding in the public interest.
- v) Non-compliance to the instructions will lead to disqualification.
- vi) Time is of essence, section 31(7) (a) (ii) due to the nature and urgency of the procurement.
- vii) Section 32 (7) will be applied to prequalified contractors.
- viii) Submission must be made **only** in English Language.
