- i- All bids must be stated in Nigerian Naira
- ii- Contractors are not permitted to bid for more than two lots. Any bidder that violates this rule shall be disqualified and only successful bidders are invited for this stage of the bidding process
- iii- The advertisement is published for information purpose, and should not be construed as a commitment or obligation on the part of the University to award these contract
- iv- The University is not bound to consider any bid and reserve the right to reject all bids at any time prior to the acceptance of a bid or cancel the procurement proceeding in the public interest
- v- Non-compliance to the instructions will lead to disqualification.
- vi- Time is of essence , section 31(7)(a)(ii) due to the nature and urgency of the procurement
- vii- Section 32 (7) will be applied to prequalified contractors
- viii- Submission must be made only in English Language.
